1. Call to order at 12:10 pm motioned by M. Theriault and seconded by M. Lu.

2. Standing Business

2.1. Motion to adopt the minutes from October 7th, 2016 motioned by M. Theriault seconded by M. Lu.

3. New Business

3.1. CAPSI Competitions Recap and Winners (M. Theriault, M. Ni, V. Kalashnikov)

- 3.1.1. OTC Competition went pretty well (V. Kalashnikov). There were 5 participants and the concerns from 1st and 2nd-year students were that both years had an EOB Exam on Tues. It would be nice to have more days of competition perhaps in the future but this might be difficult due to scheduling conflicts. Perhaps we could advertise it as complimenting your education and securing seats for PDW. The competition wrapped up by 7: 15 pm and Dr. Seto was happy with the dinner provided. The judge needed around 15-20 min. per contestant but all of our contestants were very punctual this year. Supplies were also plentiful.
- 3.1.2. Next year for PIC and OTC: we could talk to lab instructors earlier so that they could help advertise for us (S. Song).
- 3.1.3. Compounding Competition (M. Theriault): 7 teams this year and we had extra supplies. Despite the changed date, everybody showed up. We had two 1st-year students show up who were not wearing lab coats. Perhaps in the future, we could let 1st-year students borrow an upper year student's lab coat to maintain professional etiquette. We may be able to keep the number of judges

- 3.1.3.1. Cleaning-up: some of the slabs were a little dirty so perhaps next year, it would be helpful to have a judge come by to check that everything is clean before leaving (S. Song).
- 3.1.4. PIC (M. Ni): Competition went smoothly but the 5 min. pause in between each competitor was a little tight for the judge. After each competitor has finished, the judge would need to discuss with the actor whether the competitor missed anything. Other than that, it went smoothly and was easy to clean-up and set-up.

3.2. CAPSI Endowment Award (S. Song)

- 3.2.1. 9 years ago in 2007, CAPSI donated \$20k to our faculty so we have an award for PDW travelling. The faculty put the \$20k in the bank and its interest is used for the \$800 award. S. Song has been in touch with Jennifer Chatterton so CAPSI can do a better job of promoting it to the students.
 - 3.2.1.1. We have a Professional Award (which we sponsor ourselves) and Endowment Award (endowment fund that we use the bank interest for an award); application depends on when the faculty decides to send out the e-mail (K. Sin). All of these travel awards are done retrospectively i.e. the student must have gone on that trip.
