9.1 CAPSI Award of Professionalism

From:

CAPSI UBC sponsors an annual award for CAPSI members. This award is subject to availability every year based on budget. CAPSI Council must discuss every March whether the award is available for the following year. Nominations/ Call for applications for this award are sent out after September each year. This award recognizes a pharmacy student who demonstrates a high degree of professionalism in pharmacy. Any of the following demonstrates contribution to pharmacy professionalism:

- Displaying initiative in trying to promote pharmacy as a profession
- Willing to actively participate in events for the benefit of others demonstrating leadership skills
- Showing interest and involvement in any number of events/activities (from fundraising, volunteering, working to increase awareness around community about pharmacy and pharmacy students)
- Showing initiative in developing a new concept, activity, or fundraiser

To:

The CAPSI Award of Professionalism is an annual award that recognizes a pharmacy student who demonstrates high degree of professionalism in pharmacy. Examples of professionalism includes but are not limited to:

- Actively promoting the profession
- Participating in events and initiatives related to pharmacy
- Developing a new event, initiative, or fundraiser related to pharmacy

The award is subject to availability annually based on the availability of the budget.

The application form is to be uploaded on the CAPSI UBC website in October.



The deadline of the award will be determined by the CAPSI Awards Committee but must not be later than the last day of October in order to provide enough time for the plaque engraving, which shall be presented at the AGM.

A. Award Eligibility

Only CAPSI members are eligible for this award.

Under recognized students will be given preference

• The present local executive council and members of national council are not eligible for the award (including the Sr. and Jr. rep). However, if someone has previously been on council but is not on either council during the year that they are nominated, they are eligible to receive the award.

AWARD ELIGIBILITY

The applicant must be a CAPSI General Student Member.

Members of the current CAPSI UBC Council or CAPSI National Council are not eligible for the award.

B. Criteria

The most important attributes for the successful candidates would include:

- Impact and initiative in professional activities
- Dignity of character
- Creation of new programs
- Promotion of pharmacy
- Dedication to a worthy cause
- Pattern of professionalism
- Role model for colleagues

The consideration of each criterion will be based on the impact made outside of school activities, with participation in Clubs (CAPSI, PhUS, Kappa Psi, or Lambda Kappa Sigma, etc.) CAPSI activities are an asset and will be a secondary consideration. However, CLUB CAPSI involvement will be considered as CAPSI executives record attendance at CAPSI events including but not limited to CAPSI competitions, volunteering for CAPSI community education, PDW, etc.

C. Procedure



The candidate is required to be nominated by two other students. The students are not required to be CAPSI members, but must be nominating someone who is a CAPSI member. No faculty members will be eligible to nominate a student candidate.

The two students nominating a candidate will each have to provide a nominating letter (in a normal standard letter format with a limit of one page) that describes how the candidate has demonstrated the criteria set out for the award.

The candidate must then complete an award application form that involves an essay stating why he or she should win the award and a resume describing professional activities. The essay must be a maximum of 1 page each with standard margins and 12 point font. Application forms are available from CAPSI Junior representative.

PROCEDURE:

All applicants must submit a nomination form signed by two (2) nominators, both of which must be current General Student Members.

The nominators are to each provide a letter describing how the applicant has demonstrated the criteria set out for the award. The nominating letters must each be a maximum of one (1) page typed in Times New Roman font in size twelve (12). The margins of the document must not be altered.

The applicant must also complete an award application form, which consists of two (2) essays stating how the applicant has contributed to a high degree of professionalism and how the activities the applicant participated in helped develop their professional skills in pharmacy. The application form must be typed in Times New Roman font in size twelve (12). The margins of the document must not be altered.

Members of the CAPSI Awards Committee and members of the Faculty of Pharmaceutical Sciences are not eligible to nominate student candidates.

D. Voting Committee

The voting committee will be comprised of the Senior and Junior representatives and all year representatives. They shall use the marking rubric designed in August 2011 to mark all the applications.

To:

The recipient of the award shall be determined by the CAPSI Awards Committee, which consist of the CAPSI Junior Representative (Chair), the CAPSI Senior Representative, and all CAPSI Year Representatives.

The Chair will be tasked with redacting all personal identifiers from the nomination letters and essays.
